## FALL 2010 President's Report

Dear HPCA members,

*I hope by now you have had a chance to walk the recently finished labyrinth and peek over the sides of the detention pond. Hopefully those of us busy sharpening our ice skates will see enough water collect and stay in the pond to support outdoor skating – weather permitting. In the meantime, here are some updates from the board of directors.*

### Current HPCA Board projects:

- 1) Fundraising for a couple of spinners and a bouncer for the smallest among us who enjoy the playground – we need to raise about \$4000 for that equipment.
- 2) Sustainable “green” housing development resource “bank” – a collection of advice and best practices for the future homebuilders of phase 3 of the park.
- 3) 2011 Farmers Market. Response to the market was very positive. In December the board of directors will complete an evaluation of the survey data and set goals for a market next year. If we can find enough volunteer hosts
- 4) HPCA social events. We are currently developing ideas for how we can make use of the park for social activities.
